# President's Message

In my tenure on the Executive it has been my pleasure to work with a great group of dedicated individuals who have opted to devote some of their time to assist the membership of RTO/ERO District 24 - Scarborough and East York.

In particular I would like to thank Ken Turton who many of you will know is leaving the Executive after over 10 years service in many capacities, most recently as our District President. Ken, you will be missed at the executive table, and on behalf of the Executive we wish you all the best as you continue your world travels and many happy days at your cottage. Ken is an accomplished

painter, both the artistic and wall covering kind, and I know he has many projects of both kinds he is looking forward to finishing.

The job of District President is an interesting one. You represent a very diverse group of some 2000 retired teachers from the Scarborough and East York areas of Toronto from Kindergarten to Grade 13 (now, of course, Grade 12). Our focus locally spans social activities such as the spring and Christmas socials, and the fall Golf Tournament, as well as being aware and advising members on issues which affect seniors from the National and Provincial scene.

One of these issues which is currently being studied and monitored is the Fair Vote Canada/Electoral Reform Issue. In Ontario, the Citizen's Assembly, comprised of 52 men and 52 women from every region of the Province, age and cultural background, has been constituted. The Assembly will identify what principles Ontarians value most in their electoral system. Public consultations to hear what other citizens value will be held. Based on what the Assembly learns, if a change is recommended, a referendum will be held by October 2007 so all voters can have their say.

The public is invited to the Plenary sessions which are held at Osgoode Hall-York University. The agenda for each session is posted at <a href="https://www.citizensassembly.gov.on.ca">www.citizensassembly.gov.on.ca</a>. You may browse the site and join a mailing list for regular updates.






The Teachers' pension plan announced a 2.3% before-tax increase in your pension, beginning January, 2007.

# ➤ Pension Income-Spl itting Conference

RTO/ERO had a presence at the special nation conference on Pension Income Splitting that took place in Ottawa on October 3, 2006. The conference was organized by Garth Turner and several individuals, including provincial Political Action Committee member Gary Zinck. In addition to Gary, RTO/ERO was represented by provincial First Vice-President Ron Poste.

The focus of the conference was to persuade the government to allow senior couples to split pension benefits in general, not just Canada Pension Plan benefits as is currently the case, for the purpose or lowering their income tax. The CPP and spousal RRSPs are precedents for this in that they allow senior couples with unequal spousal retirement incomes to lower their income tax.

# ≻ RTO/ERO Bl ue Jays Basebal l

Over 450 RTO/ERO members, family, and friends attended the August 27 Blue Jays game against Kansas City, which the Blue Jays won 10-6, backed by Molitar's grand slam! Extremely favourable comments were received from several districts attending the game, and plans are underway to repeat this event next season. The Blue Jays' organization was very pleased with this year's turnout, and we are both looking to increase the numbers next year.

# FACT SHEET: DOWNSIZING

Retirees sometimes find themselves deciding to move to accommodation that is more suitable to their current lifestyle. This fact sheet is presented to facilitate that move and make it less stressful.

#### 1. CHOOSING YOUR NEW LIVING SPACE

Ask yourself the following questions:

- How much space do I require?
- What sort of access (ramp, elevator, stairs) does my new home need?
- ❖ Is there parking or a public transit stop nearby?
- ❖ How far will I be from services such as shopping?
- ❖ Will I be near a church, seniors' centre or fitness centre?
- ❖ What can I afford? What will my monthly costs be?

# 2. PURCHASING OR RENTING?

Now that you have chosen your new location, verify the following:

## If purchasing:

❖ What stays with the house or condominium? Have all included items listed separately and identified by serial numbers or photos. (A digital camera is useful here.)



SALE

- Are there rentals such as a hot water tank?
- Is there a furnace contract?
- Are contracts available for snow removal, lawn and garden care, etc.?
- If rural, what is the condition of the water supply and septic system?

#### If renting or moving into a retirement home:

- What present possessions do I need to move with me?
- ❖ What possessions stay with my new unit? Have all included items listed separately and identified by serial numbers or photos. (A digital camera is useful here.)

#### 3. YOUR NEW HOME

- Draw a floor plan of your new living space and sketch in the furniture you wish to take with you. Measure each item to see if it will fit or is suitable for your new life style.
- Take pictures of your present home before you start dismantling it so that you will have memories to look at in your new home. You will be able to remember more clearly a favourite chair or lamp and where it was located.
- What do you have in your present home that will need to be sold, given away or disposed of? If you intend to bequeath certain items to friends or family that cannot be accommodated in your new home, make these gifts now.
- Do you need to purchase any items for your new home? Unless it is something essential such as a bed, it may be prudent to live for a while in your new home so that you can make choices based on your new lifestyle or tastes.

#### 4. THE MOVE

❖ Make decisions about the large furniture:

Often, if moving long distances, it is easier and less expensive to get rid of some furniture that is not an antique or family heirloom and buy new furniture at your new location.

Make decisions about the small items:

Box up everything you will need. Arrange to sell everything else on consignment (usually better than a garage sale) or donate it to a charity (often with tax benefits). Possibly distribute some

items to family members or friends. Move important documents (records, deeds, jewellery) yourself if at all possible.

#### Call the movers:

Check first on their availability for your specific moving date. Usually it is best to have three or more estimates done at your residence (never over the phone). Don't sign a contract on the spot. Compare the estimates making sure you understand the details fully



such as extra services and exclusions. Avoid paying large deposits in advance. Check with your insurance company and the movers about coverage for damage or loss.

#### ❖ Before the actual move:

Mail, phone or e-mail a change of address to family, friends, subscriptions, financial institutions, credit card companies, insurance agent, Ontario Teacher's Pension Plan, RTO/ERO, government agencies such as Revenue Canada, CPP, OAS, driver's licence, health card, etc. Arrange with Canada Post to have your mail forwarded. This rerouted mail will give you further contacts to notify with your new address. Reroute your newspaper delivery. Arrange for telephone transfer and gas/hydro/cable hook-up, if applicable.

#### ❖ The actual move:

If possible, meet the movers at your new residence to have the movers arrange the furniture according to your plan. This is much easier than shuffling heavy items around later. Put kitchen supplies away first, especially perishable goods. Then hang curtains and pictures. Hook up stereo, TV, computer and telephone, reprogramming where necessary.

# The Togo Project

It started with a conversation in a Principal's office during the summer of 2002 and ended with the construction of a school in a small village in Africa during the summer of 2006. Two priests from Togo, a small impoverished country in West Africa, came to Toronto during World Youth Day to kindle a spark of love within the hearts of our community. That spark became a flame that has spread from school to parish to the business world itself. Through faith and dedication, the dreams of some have become a reality through the efforts of others.

Father Thomas and Father Nestor sat down with Principal Bob Kalisz (right) one summer day in 2002 to express their desire to establish a partnership with a school in Canada. They came away with a promise that their message and concerns would be passed on to others. Over time, the Prayer Group of Prince of Peace Parish made a commitment



to assist the school with such a partnership. "Free the Children", the youth organization started by Toronto's Craig Kielburger, also gave their support by providing tax receipts for money collected through the school or parish. The word has spread and thousands of students in over fifty Toronto schools have now been involved in different aspects of the Togo partnership. To date, over \$200,000 has gone into The Togo Project.

Last year, a program was established through "Free the Children" called "Life in Action" whereby villages in developing countries are selected and schools built with funds raised here in Canada. Inspired by this program, the grass-hut school in the village of Keve in Togo was selected by the Prince of Peace family of schools as a project site. With a population of over 300 students, an 8-room school would be required. Although the present school is Catholic, individuals from all backgrounds are accepted at the school.

The school was completed this past August by workers from the community around the village of Keve. To date, \$64,000 has been spent on construction with final donations being dedicated to building washrooms and assisting with tuition for the students. A "Book of Life" is being prepared for the school outlining the background story of involvement, letters and mementos from children here in Canada and an opportunity for others to help maintain the school through donations in memory of loved ones.

Here is another example of "Good News" that is having a tremendous impact on so many people. Students in Toronto have become "empowered" to help those beyond their local schools through the assistance of their teachers and so many other members of the community at large. The Togo Project demonstrates how words can be transformed into action and actions can transform the lives of children, not only in Africa but here at home as well.

# **UPDATE ON MY NEW KIDNEY**

In December 2004, *Beyond the Blackboard* published an article written by my husband Glenn and myself. In the article, A PRECIOUS GIFT OF LOVE, we recounted the miraculous act of our daughter donating a kidney to me. Two years on, your editor has asked for an update on how our wonderful daughter and I are doing since this procedure took place two and a half years ago.

I still find it hard to articulate the sense of relief and freedom I feel every single day! I was on dialysis for almost three years before the transplant took place. For three days each week I arrived at the Dialysis Clinic before 7:30 A.M. By the time I was hooked up to the dialysis machine, had been given three and a half hours of blood cleansing and then unhooked from the machine, it was well after noon by the time I was back home. I was usually tired and often slept most of the afternoon. I always felt during this time that I was one of the lucky ones. The nurses kept warning me that dialysis patients almost always eventually were subject to high blood pressure, heart problems, asthma, and, at some point, diabetes. Luckily for me, this never happened.

I still cannot believe the change in my health and my general outlook on life. When we wrote the 2004 article, I was giving blood for testing each week and visiting the Transplant Center once a month. Right now I visit the Transplant Center at St. Michael's Hospital every nine months and have my blood tested every three months. My medication dosage (mostly anti-rejection drugs) has been reduced but I still take a lot of pills daily. My nephrologists are very pleased with my progress and I have had no problems with rejection of my new kidney; the first year seems to be the crucial one for rejection of transplanted organs. Of course, my immune system has been seriously compromised. I am not able to look after any type of pet because of possible bacterial reaction. I am allowed to eat any foods except sushi and grapefruit products. Previously I was on a tightly restricted diet: no bananas, oranges, tomatoes, nuts or peanut butter. I could have boiled potatoes if they had been soaked in water for at least four hours.

Glenn and I worry terribly if Stephanie has a day off work due to illness or even if she seems to have a cold. However, she is very healthy and active and is totally involved with her career and her family: husband Dave, daughter Melissa, a Great Dane, a Miniature Dachshund, two puppies, a cat, plus one or more house guests most of the time.

All three of us have become very involved in promoting awareness of the great need for people to sign donor cards. On several occasions we are asked to speak about my transplant. Our latest talk was at the University Women's Club of Toronto; we found these retired women expressed much interest in signing donor cards. I had invited the Information Officer from the Trillium Gift of Life Network and the four of us fielded many questions. A very articulate retired judge (she later told me she was 92) asked pointedly whether a kidney from a person her age would ever be transplanted into another person. Callie carefully replied that, yes, a healthy kidney from an older person might well be used to help save an older person's life. She, as well as all three of us, tried to convey the following idea: everyone, no matter their age, should consider themselves a potential donor, but, ultimately, the ability to donate depends on the health of the organ(s) at the time of death of the donor. Our audience was amazed to hear that one donor could save 7 lives (organs) and enhance the lives of 77 people (tissue)! We told them that the oldest Canadian organ donor was 90 years old and the oldest tissue donor was 102!

We stress the fact that donor cards are available at provincial driving license offices or one can register his/her intentions at The Ministry of Health. Donor cards are also available at Trillium Gift of Life: 1.800.263.2833. The TGOL Network delivered 100 cards to me the day after I phoned them. We always take a lot of donor cards with us and are surprised at how many people say they have always intended to sign cards but have never done so but now they will.

Our daughter is very forceful in getting her point across to people about signing donor cards. Her father teases that he expects to soon see her down at Dundas Square exhorting people to sign donor cards! She has been contacted several times by people who are contemplating donating a kidney to a relative or friend and they want to discuss it with someone who has done this. She is so very positive about this that it seems to be contagious. She points out that her parents can once again take long trips whenever they wish. I have heard her conclude her remarks on a panel by saying, "Hey, guys, you need only one kidney. Why not consider donating one to a friend or relative or someone else who needs one?"

Exciting things are happening with transplants. A case of an anonymous donor made the news this year. The term "paired donors" is now getting a lot of attention. Recently two couples (previously unknown to each other) participated in the pairing of donors and recipients. The donor of each couple was compatible with the recipient of the other couple but not with their own spouses. Renowned transplant hospitals, such as Toronto General and St. Michael's, are interested in promoting this idea and enlarging the scope to include many couples.

Legislation is now pending in Ontario which might well help increase the number of people who sign donor cards. One such bill (by a Conservative MPP), called Mandatory Declaration, would require a person, when renewing a driving license, to state Yes or No to signing an organ donor card.

The Trillium Gift of Life Network has been given the mandate of establishing and managing waiting lists for recipients of organs and tissue and to maintain a fair system of allocation. I quote their advice: "Sign a donor card and keep it with you. Talk to your loved ones about this as they will be the ones asked for final consent in the event of your death".

Glenn and I work as volunteers for the Patient Services Committee of the Kidney Foundation of Canada. Last year we worked at organizing and helping run the Kidney Symposium held in Whitby where over 150 renal patients and caregivers were in attendance. We attend meetings, write articles, work on their Bursary Program and, in general, try to help kidney donors and recipients.

As I look back on my lifestyle and general health since my transplant, I marvel at the many changes that have happened in our lives. Glenn and I can once again travel. I am no longer tired all the time. In my mind, I thank my brave and loving daughter Stephanie every morning when I awaken to the new day.

# IRELAND IN THE SPRING

The best thing about going on a trip abroad is discovering something unexpected. That's what happened to my wife and I when we visited Ireland in April this year.

We were driving around the country exploring the history, looking for some connection with our cultural roots and enjoying a carefree holiday. We had landed in Dublin and wandered across the country to Donegal in our Toyota rental car. We had no specific destination, no schedule and so, when we stopped for directions and a man told us about Slieve League (Grey Mountain), the sound of high cliffs aroused my curiosity and we were off.

They are said to be the highest and one of the finest marine cliffs in all of Europe at 1,972 feet. He gave us the directions and we made our way to the first of two parking lots. The leisurely walk along the narrow road towards the top had several twists and turns and we were glad we had not driven up to the top. The solitude of such a place caused me to reflect about the past and the isolation that local individuals must have experienced living in such a desolate area. The scenery as well became more and more incredible - especially the views over Donegal Bay. Once we reached the top, and passed the second parking lot, we had a breathtaking, but extremely scary view, of the wild Atlantic waves that were a three hundred metre drop straight down below us.

Unlike the Cliffs of Mohr in County Clare which are absolutely gorgeous, Slieve League does not have the crowds or the commercial overtones attached to it. This was definitely a part of Ireland that is well worth the visit.

Next, while driving north-east and trying to avoid going through the town of Letterkenny we ended up in the middle of it. We pulled into the Shopping Centre parking lot to have some lunch and get our bearings. Having a brief discussion with some people in the parking lot, we discovered we were still in Donegal and should see Glenveagh National Park which was 24km north-west of Letterkenny. There was a unique castle on the grounds. We thanked them, and having checked our map, were off again on another unexpected adventure.

Having spent part of our stay at the Visitor Centre to get some background history, we took the shuttle bus to Glenveagh Castle which was built between the years 1870-1873. Surrounding the Castle there are 10 hectares of exotic gardens. This estate has been referred to as "Europe's most enchanting setting in a place of solitude"... considering the entire estate covered almost 20,000 hectares of mountain, lakes, glens and woods.

We spent a wonderful afternoon wandering around the grounds taking in the contrast of the wild and rugged landscape that surrounded the castle grounds and the carefully nurtured gardens within. This was another isolated wonder that we found off the beaten track in Ireland and must not be missed by any visitor with time on their hands.

While staying at a B&B near Dunlewy we went off looking for a place to have dinner. We found a pub. They no longer served food - only drinks - due to the late hour. They did, however, provide us with directions to Leo's Tavern which was nearby. We had a lovely supper around 7:00 p.m. and enjoyed the cozy atmosphere thinking how unfortunate it was that the band area was empty. Behind me was a full size poster of Enya. We didn't realize at the time that Leo was Enya's dad and this was the home of Clannad. The lady at the B&B told us that Enya played there during the Christmas holidays for the locals. We came back the next morning to photograph the place, still excited about another unexpected experience.

A lot of people would not drive in Ireland but I found the experience exhilarating. An adventure by car and staying at B&B's is well worth the time and effort. It's fun getting lost and then finding the place you wanted to stay at or the castle you wanted to visit. I look forward to another visit to Ireland and more unexpected adventures.

Observers do not vote, although they may speak with their Senator's approval. Motions for changes come from the Executive at Provincial Office, or from the Senators, and are not in effect until they have been voted on.

Attending Senate on your behalf were Gary Fick and Ken Turton as Senators 1 and 2; and Hal McCullough and Brenda Fick as Observers 1 and 2.

## **Political Action:**

The P.A.C. has been very busy this year working on such issues as mortgage fraud, child care, the electoral process, pension income splitting, market value assessment, and increasing member participation in municipal elections through an extensive set of strategies and guidelines.

A Fact Sheet on mortgage fraud will be prepared, and an article concerning this form of fraud will be written for *Renaissance*.

#### RTO/ERO Goals:

The provincial Executive remains committed to the following five goals:

- ♦ Service to Members
- ♦ Marketing RTO/ERO
- ♦ Expanding Relationships
- ♦ Corporate Structure
- ♦ Financial Accountability

The Provincial Executive has continued to deal with the implementation of provincial priorities especially in the areas of governance and risk management and political advocacy. On the political front the Provincial Executive met with the Minister Responsible for Seniors' Affairs, and reviewed some

issues such as the impact of Property Assessment, Housing and Long term Care.

Areas in the ongoing management of the organization include:

- ♦ Setting parameters for the membership survey
- ♦ Overseeing the RTO investment portfolio
- Development of a building maintenance plan to replace the aging heating and cooling systems
- Donation to the South East Asia disaster relief fund through the Red Cross and a \$3,500 donation to the Nelson Mandella Children's Fund (Canada) funded by a donated picture raffle and a rebate from the RTO Blue Jay Game receipts.

## Health Services and Insurance:

- premium changes will begin February 1, 2007 (will save RTO/ERO \$40,000 on postage)

# Pension and Retirement Concerns:

The 2005 Funding Valuation was filed with the Financial Commission of Ontario. The terms of agreement:

- members' contribution rates will increase 2% Jan. 1/07 and 0.3% Jan. 1/08
- the government partner to contribute 2% more Jan. 1/07; a further 1.1% on Jan. 1/08
- for 2008 only, OTF will offset members' contributions by the use of the remaining \$76 million credit from the 1998 negotiations. A further 0.8% increase effective Jan. 1/09
- total contributions for teachers and other contributors to the fund will not exceed 15% (should future increases be necessary)
- there will be no impact on members receiving pensions

#### 95 Day Rule:

- retirees will be able to work for a school board in any capacity for no more than 95 days in each of the first three years in which they return to work
- they need not be consecutive years nor must they begin immediately after retirement
- they do not include any years taught during the 5 year window (2001-2006)
- be aware that even a half day worked counts as one of "the first three" years after retirement
- after studying the Bigsby Case from Alberta, which contested a similar rule for returning to teaching after retirement, the committee and executive decided it was not in the best interest of RTO/ERO and its members to pursue this path

#### Recruitment

## Retirement Planning Workshops

These are sponsored by RTO/ERO have been well-attended and well-received by interested, active teachers. Member Services assists the Districts presenting R.P. workshops with some financing and provides materials at cost. RTO/ERO (and the Toronto Districts) continue to offer these introductory workshops that are a most important recruitment tool as they increase the visibility of the work of Districts with local active teachers. #### Travel

#### Project - Service to Others:

The new Scholarship Awards programme has been welcomed by our members. In this first year, 210 applications were received and 25 \$1000 awards were granted. "Step children" and sons and daughters-in-law are now eligible to apply.

District 24 was successful in presenting a motion to "offer the scholarships to worthy candidates pursuing a career in teaching from an accredited teacher training facility". *Teachers are supporting teachers!* 

Our District had 2 applicants but neither was successful this year. Try again!

I write articles in each of our District's newsletter to keep you informed of information as it is sent to me from the Provincial Committee. Once a year I attend a one day conference in Toronto where all RTO's HSRs are invited to meet, learn about the latest issues and the Provincial Committees new initiatives, and to share member concerns. In the past year I received only a dozen or so requests for assistance. However, in all cases, if I didn't know the answer immediately, I sought it out and then called or e-mailed the member with the required information, usually the same day.

This year's seminar is a talk by a professional from the Liver Foundation which, I'm told, is highly educational. #### Heal th Services and Insurance



Hello again! I have several pieces of information and reminders to share in this issue, as well as a new initiative being put forth by your Provincial

Health Services Committee. Check our June newsletter for RTO's helpful new fact sheet entitled "Vacation Checklist". Also, you have a short time left to register for our fall health seminar presented by the Canadian Liver Foundation. See page 9.

The first item concerns our Travel Plan. It would be prudent to review your small Out-of-Province/Canada booklet and make note of the following statements that, when not followed, have created problems for some of our members:

"Trip cancellation claims must be reported to Johnson Inc. Plan Benefit Claims before the scheduled departure date from your province of residence". And, "If World Access Canada is not contacted within 48 hours of the emergency, payments will be limited to \$2000 per insured person per trip." Regarding claims of \$500 or less: at present you pay directly and then contact Johnson for reimbursement. This money is not a deductible. The HS&I Committee recommends that plan participants always contact World Access Canada Inc. within 48 hours of all medical emergencies. Please note: Effective January 1, 2007, ALL claims will be paid by WAC. E-mail me if you would like a list of documents that could be required in connection with a Trip Cancellation claim.

The government has launched a new website that provides a single source of information about programs and services for seniors offered by all levels of government and local community agencies. The address is <a href="https://www.seniorsinfo.ca">www.seniorsinfo.ca</a>.

A recent study has found that people could adjust their body clocks when travelling to different time zones by altering their light patterns. This can be done by wearing sunglasses or seeking natural or artificial light. To help combat the effects of jet lag, British Airways has added a jet lag calculator to their website at: <a href="https://www.britishairways.com/travel/drsleep/public/en\_ca">www.britishairways.com/travel/drsleep/public/en\_ca</a>. Answer a few simple questions and the calculator will provide you with a personalized schedule to help you alter your light pattern.

In February 2006, 39,135 RTO members were covered for at least one of our health plans. Of these members, about 25% have their drug claims submitted electronically by their pharmacist vs. mailing a paper claim for reimbursement. The cost of the

former is less than half the cost of the latter! Help keep your premiums down and save yourself some paper work at the same time by asking your pharmacist to e-file for you.

I had planned making RTO's new Wellness Initiative: "Walking - the Activity of a Lifetime" a focus of this article, but you are already informed, having read page 22 of the fall issue of Renaissance. The government's website www.active2010.ca is a great resource! It tells you the physical and mental benefits of walking, safety concerns, important stretches to incorporate into your walk, daily and weekly goals, a sample walking program for those just beginning, and a chart to log your progress. If you are unable to obtain a print-out of these pages from a friend or the public library, you may request a booklet from Ontario's Queen's Printer. RTO is making available deluxe "Minder" pedometers with panic alarm for \$21 (delivered to your home) for a fraction of the retail price. Contact Melanie Johnson at RTO to order them for your family. (Psst! They'd be a useful stocking stuffer.)



Suggestions were provided in Renaissance to get you started on your walk to health. Some people lose interest after repeatedly walking the same path, so try

to vary routine. I recently discovered that Toronto's Mount Pleasant Cemetery is an interesting place to be active. Pick up from the office its "Historical Walking Tour" brochure and learn while you walk and get healthier! Toronto City Hall has available free booklets entitled "Discovery Walks". Each provides a map and little bit of background on a variety of cultural districts in the city. Other pleasant places to walk are the old Guild Inn land in south Scarborough, Edwards Gardens at Leslie and Lawrence, or Toogood Pond in Unionville.



#### **Pensions**

On September 26, I attended the Pension and Retirement Concerns Representatives Workshop in downtown Toronto. Representatives from the RTO and Ontario Teachers Pension Plan presented information and took our questions.

We were asked to draw your attention to the fact that:

- you must apply for your Old Age Security in order to receive it. (6 months in advance of your 65<sup>th</sup> birthday is recommended)
- for OAS recipients who have low incomes, there is an Income Supplement available for which you must apply.
- RTO has a library of Fact Sheets, available free of charge, to help with these and a number of other topics. The list of topics was printed in our June 2006 Beyond the Blackboard and is available on RTO's members only website <a href="https://www.rto-ero.org">www.rto-ero.org</a> or by calling Liz Timms at 416.962.9463 x221 or 1.800.361.9888 x221 with a request.
- clawbacks of OAS begin at incomes of \$62 144 or more

There are about 163,000 active and 101,000 retired members in the OTPP, which has about \$96 billion in assets.

#### Working After Retiring

The rules that follow apply only to positions with employers who are members of the Ontario Teachers' Pension Plan. (For all other employers, there are no limiting factors.)

- see page 19 for information regarding the 95 days of work in a year.
- ♦ after age 68 there are no rules limiting the number of days you may work.
- if you exceed the number of days that you are allowed to work, your pension will stop and you will have to reapply.

#### Dealing With the Valuation Shortfall

When teachers retire, their present and future pensions are determined by the terms governing that pension on the date they retired. Any changes to the Ontario Teachers Pension Plan to deal with a valuation shortfall apply to active teachers, and are presented here only for your information.

Every three years the Teachers' Pension Plan Board must create a valuation to

determine if there are enough monies in the plan to pay current and future pensions. For a number of reasons, such as low interest rates, new and expensive improvements to the plan, increasing longevity of pensioners, earlier age of retirement and so on, the valuation has described a future shortfall, even though there is about \$96 billion worth of assets in the plan.

To resolve the shortfall, the partners, the Ontario Government and the Ontario Teachers Federation, decided to phase in over the next three years, an increased payment into the plan by active members with matching funds from the government.

Our plan is not allowed to have an actuarial deficit nor surplus. During the valuations of the 90's when large surpluses were found, they were used, first to fund the unfunded liability against the plan created by our cost of living benefit during the years of high inflation, and second, to increase benefits to plan members such as a permanent 85 factor, the best 5 years for all, and greater separation from the CPP. We used up all of the actuarial surpluses. Then interest rates fell, many teachers retired, and the valuation showed a deficit, which, it is hoped, the increases in contributions will alleviate.

In addition, a revised method of defining surplus in the plan has been agreed upon for future valuations. This is to provide a cushion, preventing the use of all of an actuarial surplus, as currently defined, being used, and to make less likely a deficit requiring an increase to contributions or reduction of future benefits. The new definition of full funding was made allowable by the passage of new provincial legislation governing pensions such as ours.

The decision to increase contributions was made by the partners. The OTF is planning to survey current active members to see what they want to have happen if there is another deficit in the plan.
