
## PRESIDENT'S MESSAGE



Due to restrictions caused by COVID over the past three years, the financial report showed a larger than normal bank balance that will be used to benefit members by continuing with and supporting Executive initiatives.

#### **Membership Certificates**

RTOERO District 24 had a membership total of 3,054 as of September 1, 2022. We have nine individuals who are over the age of 100 and two people in this group who are 109. We are proud of our growing membership and appreciate the ongoing support.



For the first time to my knowledge, we will be recognizing individuals who have been members of RTOERO District 24 for twenty-five years or more. We have one individual who has been a member for 49 years. Congratulations to all these members. During the summer, I signed 127 certificates for members who have reached membership milestones. We have 81 members who have reached 25 years; 14 who have reached 30 years; 29 who have reached 35 years; 2 who have reached 40 years; 1 who has reached 45 years and one who has reached 47 years!! Congratulations to each one for being such valued RTOERO members of our District and community.

Those members who reached a milestone and attended the Annual Meeting and Luncheon this year were presented with their certificates in person at the Annual Meeting luncheon. For those members unable to attend the luncheon the certificates will be mailed out.

## Scholarship Recipient in District 24, Geneva Mariotti

RTOERO believes in the power of our community to secure a better future and we're committed to helping secure better futures for students for each other, and for seniors in Canada. One of the ways we work towards achieving this goal is through our post secondary scholarship program. This year, Geneva Mariotti, nominated by her grandmother, Nona Mariotti, was awarded a \$3,000 post secondary scholarship in the field of Cognitive Science.

Geneva Mariotti began her studies at York University in the Bachelor of Science program in Specialised Honours Psychology, where she largely focused on experimental neuropsychology and cognitive neuroscience. She quickly became interested in participating in laboratory research in the lab of Dr. Joseph DeSouza who studied the neuropsychology of dance in Parkinson's Disease as well as vision. Geneva assisted in the analysis and writing of various neuroscience projects, including a project of her own investigating facial emotional recognition in Parkinson's Disease. During her 3rd year at York University, Geneva began working in the lab of Dr. Jennifer Ryan at the Rotman Research Institute, on projects using eye-tracking and MRI methods to understand various aspects of cognition such as memory and learning in older adult populations. As she enters her 4th and final year at York University, Geneva is beginning her thesis project in the lab of Dr. Dale Stevens, where she plans to investigate conceptual representations within the brain.

Following her 2023 graduation, Geneva hopes to begin a Masters and Ph.D. program in cognitive neuroscience, where she will study the cognitive neuroscience of ageing. She hopes to become a leading scientist in the field of ageing, and to give everyone equal opportunities to live long, happy, and healthy lives. We wish Geneva much success in her studies.

#### **SCAM ALERT!**

Identity Theft: Scammers are always on the lookout to collect or reproduce your personal information to commit fraud. Thieves can make purchases using your accounts, obtain passports, receive government benefits, apply for loans, and more. This could turn your life upside down. Fraudsters use techniques that range from unsophisticated to elaborate. Offline, they can go through trash bins or steal mail. Online, they can use spyware and viruses, as well as hacking and phishing, online usernames and passwords, driver's licence number, and passport number. They look for credit card information, bank account details, full name and signature, date of birth, social insurance number, full address, mother's maiden name etc. Ensure your identity remains yours alone!

## **How Do I Protect Myself?**

- Never provide your personal information over the phone, via text message, email or the internet.
- Avoid public computers or Wi-Fi hotspots, such as in coffee shops, to access or provide personal information; they put you at risk
- Create strong and unique passwords for each of your online accounts. Password-protect your devices and home Wi-Fi network.
- Use a secure and reputable payment service when buying online—look for a URL starting with "https" and a closed padlock symbol.
- Avoid giving out personal information on social media. It can be used along with your pictures to commit fraud.
- Always shield your PIN when using your card. If you hand it over to a cashier, never lose sight of it.
- Shred and destroy documents with personal information.
- Never provide personal information to unsolicited telephone calls.



## **DISABILITY TAX CREDIT**

Something which you may wish to investigate when you are preparing your income tax forms in April is the Disability Tax Credit Form T 2201.

When we see the term Disability it can trigger many feelings such as I am not disabled, I can do anything I want, I do not need welfare. First the purpose of this tax credit is to recognize that even though you are able to function, it might require you to spend additional funds in order to "do everything". The tax credit will reduce the income tax you would normally payfor these additional expenses.

How does one find out if the tax credit applies to your situation? You can explore with your doctor the requirements for this credit and if your doctor believes you may qualify, the T2201 application form can be submitted to the CRA for consideration. The application may be found along with specific qualifiers from the following website: (Doctors will charge a fee for completing this application. This fee may be submitted as a medical expense when filing your income tax.)

If you are approved for the tax credit and have been certified by your physician to have been afflicted for a long period of time, the CRA will reassess your tax returns for the past 10 years and refund partial taxes that you have paid. This can be a significant amount of tax-free cash to assist with extra expenses needed to make your life easier.

There are companies which will assist you with the process by doing a pre application interview and if they believe you should be eligible, they will work as your agent in dealing with your physician in completing the medical portion of the application as well as with the CRA in submitting the application. They work with you on a contingency basis. If you are approved and receive a refund, you must agree to pay them a portion of your refund. While the percentage may appear significant if CRA deems you to not to qualify, you pay nothing to the agency. If you are deemed to qualify by the CRA, going forward you may claim the Disability Tax Credit when filing your annual taxes and the company gets no additional fee.

I was skeptical when I heard of this but can assure you that, if you are eligible, a substantial refund can be received.

## **Changes in Our Health Insurance**

I want to let you know about an important change to the process for submitting insurance claims and getting reimbursed. This change comes into effect <u>Jan. 1</u>, <u>2023</u>. Right now, the deadline to submit an insurance claim is the end of the *next* calendar year after the date in which you incurred the expense. For example, 2021 receipts can be submitted until <u>Dec. 31, 2022</u>.

Most members submit their claims almost immediately. But some members wait until year-end before sending in their claims. This has a number of negative effects. It means a backlog of claims at certain times – which means slower service for all members. It also makes it harder to predict the total claims for a given year, since it's another year before we receive all of the claims.

Starting <u>Jan. 1, 2023</u>, the RTOERO policy will require you to submit your claims within <u>six months</u> from the date the expense was incurred. For example, if you had a massage on <u>Jan. 7, 2023</u>, you have until <u>July 6, 2023</u> to submit your claim. Or, if you had a dentist appointment on March 1, you have until Aug.31. Expenses incurred on and before <u>Dec. 31, 2022</u> must be received by <u>June 30, 2023</u>. For items such as eyeglasses or orthotics, the incurred date is the date the item was paid in full. For services such as massage or physiotherapy, the incurred date is the date the service was rendered.

RTOERO continues to offer many convenient ways to submit your claims. It is most convenient to use the claims portal to submit online. Have your claims submitted directly by your pharmacist and dentist. Some paramedical providers and opticians also offer the option to submit your claim directly. We also continue to accept claims by mail.

On May 1, we improved our service to members again! The travel portion of the Extended Health Care Plan now covers you for trip cancellation, interruption or delay benefits if you or your travelling companion have a positive test result, become ill or die due to contracting COVID-19.

Municipal Council and school board elections will take place on Monday, October 24, 2022.

#### Joint Letter to the Government of Ontario

On August 30, 2022, RTOERO joined Alzheimer Society Ontario, International Federation on Ageing, CanAge, Fédération des Ainés et des Retraités Francophones de l'Ontario, International Longevity Centre Canada, and Save Your Skin Foundation to express grave concerns about the government's intentions to accelerate the passing of Bill 7. This Bill is intended to remove senior patients from hospital beds and place them in long-term care homes not of their choosing. In some instances, this could mean separating patients from family by hundreds of kilometres.

## Our Theatre Trip to Stratford, Ontario by Ron Foster

On Wednesday, June 8, 2022 a group of eager RTO 24 members joined in an almost surreal experience – that of



travelling once again to the Stratford Festival to enjoy a performance of the Broadway hit show, "Chicago". (The last two plus years since the previous RTO excursion were filled with anticipation of just such a trip.) We boarded our comfortable coach at Kennedy Commons and, after a journey across the city, we were spirited away to Stratford, courtesy of the capable staff of Mary Morton Tours.

We enjoyed a delicious served meal at the Queen's Inn, after which we were taken to the Festival Theatre for the performance. The Stratford Festival has gone all out this year to impress its patrons with a dazzling display of horticultural delights. The formal gardens have never looked better!

The production of Chicago has been carefully directed and choreographed by the talented Donna Feore. Ms. Feore stated in her forward that, "If you sat down today to write a musical that might speak directly to our time, a time of image manipulation, open corruption, and the abuse of truth, you would probably come up with *Chicago*."

The show is filled with the jazz, sex, and booze for which the era of the Roaring Twenties is justly famous. The vaudeville tradition of the early 20<sup>th</sup> century came alive as the capable cast of actors, singers, and dancers gave their best on Stratford's famous thrust stage. Ms. Feore had the opportunity to reimagine "Chicago" to fit the Festival's unique stage. The design of the Stratford stage and the "theatre-in-the-round" design draws one into the production as an immersive experience. Of course, audience favourites such as "All That Jazz" and "Razzle Dazzle" were performed with panache and vigour. As an audience member, I was particularly attracted to the song, "Mister Cellophane" performed by Steve Ross (in the role of the hapless Amos Hart). His sincerity is unrivalled.


#### **Book Club C**
